Premier Insurance Company Limited (the Company) – in Administration

Further to our letter dated 17 October 2025 regarding the Company's disclaimer of live policies effective from 00:00 GMT on 1 December 2025, please note that from this time policyholders will no longer have a valid insurance policy and no claims occurring after this date will be covered.

We write to you with the support of the FCA to ask you to take all reasonable steps to ensure your policyholder clients are aware that their motor insurance policy with the Company will cease to be effective as of 00:00 GMT on 1 December 2025.

This is critical to avoid customers unknowingly driving without insurance.

The FCA have agreed that it would be reasonable for us to request you to provide the below information to us by 12:00 GMT on Friday 21st November 2025:

1. List of all live policies as at 00:00 GMT of 1 December 2025 including policyholder names and addresses
2. List of policyholders that have effectively been informed that cover will cease (in the same format as 1 above)
3. List of exceptions where the policyholder has not effectively been informed that cover will cease (in the same format as 1 above)
4. A summary of the actions that have been completed and which are planned (if any) to contact policyholders
5. An explanation as to how you have assessed the effectiveness of your customer contacts i.e. whether your customers have understood the ending of their cover

We require that before 11:00 hours GMT on Thursday 27th November 2025, you provide us with a list of:

1. all live policies as at 00:00 GMT of 1 December 2025 including policyholder names and addresses
2. policyholders that have effectively been informed (in the same format as 1 above)
3. exceptions where the policyholder has not effectively been informed (in the same format as 1 above)

These lists will be used by the joint administrators in a court application to be filed on the morning of Friday 28th November 2025 an illustration of what may be submitted to court is as attached in Appendix A.
