### **Premier Insurance Company Limited (the Company) – in Administration**

#### **Legal Requirements**

On 14 October 2025 the Company entered into Administration and Freddie White and Bradley Chadwick were Appointed Joint Administrators. The Appointment was made by order of the Supreme Court of Gibraltar. I and my Joint Administrator are licensed to act in Gibraltar as Insolvency Practitioners. Formal notice of our appointment is attached.

We are currently formulating our proposal for the conduct of the administration. This will be sent to creditors in due course along with the notice convening a meeting (to be held remotely) of creditors at which approval of our proposals will be sought.

The notice to convene the meeting will provide details of the date and time of the meeting as well as instructions on how to access the meeting remotely. It is presently intended for the meeting to be held on Monday 1<sup>st</sup> of December 2025 at 11.00am GMT, but this will be confirmed in the formal notice.

#### **What Does This Mean For You**

1. If you currently have made a claim on your policy, you should see no change in how your claims are processed, they continue to be handled by the Company's claims team and settlements will continue to be made via the Company. The Financial Services Compensation Scheme have declared the Company to be in default and may protect eligible policyholders, by assisting with any shortfall not met by the Company. As stated above this will have no impact on the processing of claims as all claims related matters continue to be dealt with by the Company in the normal manner.
2. Any new claim arising from a policy of insurance issued by the Company should be notified in accordance with the policy terms and conditions.
