#### **Legal Requirements**

We write to inform you that we are required by the provisions of the Gibraltar Insolvency Act 2011 to advise you that our proposals for the conduct of the administration of the Company were approved by a Meeting of Creditors on 11<sup>th</sup> December 2025. We attach a copy of the statutory notice and the accepted proposals.

#### **What Does This Mean For You**

1. If you currently have made a claim on your policy claims continue to be processed by the Company's claims team.
2. Regrettably, the Company has insufficient assets to meet insurance creditor claims in full. As per the accepted Administration Proposal a partial distribution to insurance creditors of 65% of an agreed claim will be made from the assets of the Company.
3. The Financial Services Compensation Scheme have declared the Company to be in default and should protect policyholders who are eligible for protection in accordance with the Compensation Scheme rules, by assisting with any shortfall not met by the Company. Any queries relating to the notification of a claim or progression of a case should be made in the normal manner.
4. If you have a claim for services provided but which remains unpaid – please provide details of the amount owing to you at the date of appointment, 14<sup>th</sup> October 2025.
